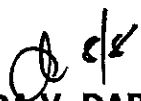

**PRODUCT SPECIFICATIONS**

- Color: Clear or Blue
- Bactericidal
- Net Content: 900 mL – 1,000 mL in rigid plastic bottle
- Fully Miscible in Water
- Not Chlorine Based
- Does not contain Inorganic Acids if acid based
- Non-volatile Content: 5% (w/w) max., using analytical method
- Viscosity: 114 cP at 25°C min. Using Ostwald Method

**EVIDENCE AND VERIFICATION**

- FDA Certificate of Product Registration/ Product Notification Number (Shall be indicated on the label).
- FDA Certificate of License to Operate (LTO) Number as Trader/Distributor/Manufacturer
- Three (3) bottles shall be submitted to the BAC during opening
- Technical dossier from the manufacturer.
- Test report from a recognised body showing compliance.
- List of all product chemical component constituting greater than 0.1%.
- Documentation from the manufacturer stating that it does not contain inorganic acids (e.g. hydrochloric acid, nitric acid, sulfuric acid, phosphoric acid) by submitting information on identity and chemical and physical properties, health hazards and precautions for use and safe handling as well as disposal.
- Testing for the composition of the product can be provided by SGS Philippines.
- Instructions for use of the product and disposal of container.

**PACKAGING**

- Twelve (12) bottles per box

- Shall conform with the Consumer Act of the Phils. (RA 7394)

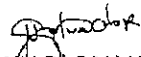

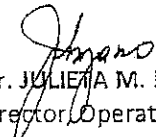

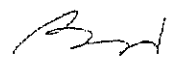
