SCHEDULE OF REQUIREMENTS	The Chairperson wished to know the warehouse capacity of the Mouse, Optical. The PMOIC answered that the warehouse capacity of Mouse, Optical is 5,800. He likewise reported that the amount of requirement from last year has went up twice.
