

OTHER MATTERS	<p><i>The Chairperson briefed the BAC on Advance Paper Corporation's disqualification on past biddings.</i></p> <p><i>Advance Paper Corporation stated that they will no longer be able to provide a colored variety of the Folder, Fancy with Slide, A4.</i></p> <p><i>Advance Paper Corporation discussed their issue on the Truck Ban Ordinance when conducting deliveries for government agencies. The company stated that they already expressed this concern to former Executive Director, Ms. Bingle B. Gutierrez, in writing, asking for assistance to mitigate this. Advance Paper Corporation stated that this problem mostly affects trucks having apparent large loading capacities.</i></p> <p>The Chairperson instructed Advance Paper Corporation to send a follow up letter regarding the presented issue. The supplier committed that they will be sending a follow up letter after the season of Lent.</p> <p>Atty. Bacal suggested having a meeting with the other affected suppliers being present.</p>

	<p>Advance Paper Corporation discussed another issue with the delivery. The supplier stated that they are being instructed to seal their deliveries in an out-of-the-budget plastic wraps. Upon arrival at the warehouse, these deliveries will be stored in bags. Said bags will be sealed with plastic wraps again. Advance Paper Corporation explained that the sealing of the items are time consuming and that the plastic wrap is costly, given that it is not covered in the contract.</p>
