



### **Invitation to Bid**

for the

### Construction of ASCOM Facilities at Camp Aquino, Tarlac for the Bases Conversion and Development Authority (BCDA)

#### **Public Bidding No. 20-022-3**

1. The Bases Conversion and Development Authority (BCDA) and the Procurement Service – Department of Budget and Management (PS-DBM), through the General Appropriations Act FY 2020 intend to apply the sum being the Approved Budget for the Contract to payment under the contract for the following:

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The PS-DBM and BCDA now invite PhilGEPS registered contractors with valid and current Philippine Contractors Accreditation Board (PCAB) License of at least Category "AAA" and classification "Large B" for General Engineering.

Bidders should have completed a contract similar to the Project equivalent to at least fifty (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly in Clause 5.4 of Section II. Instructions to Bidders. For purposes of this project, similar contracts shall refer to the contracts involving Construction of Multi-Storey Building.

 Bidding will be conducted through open competitive bidding procedures using nondiscretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
