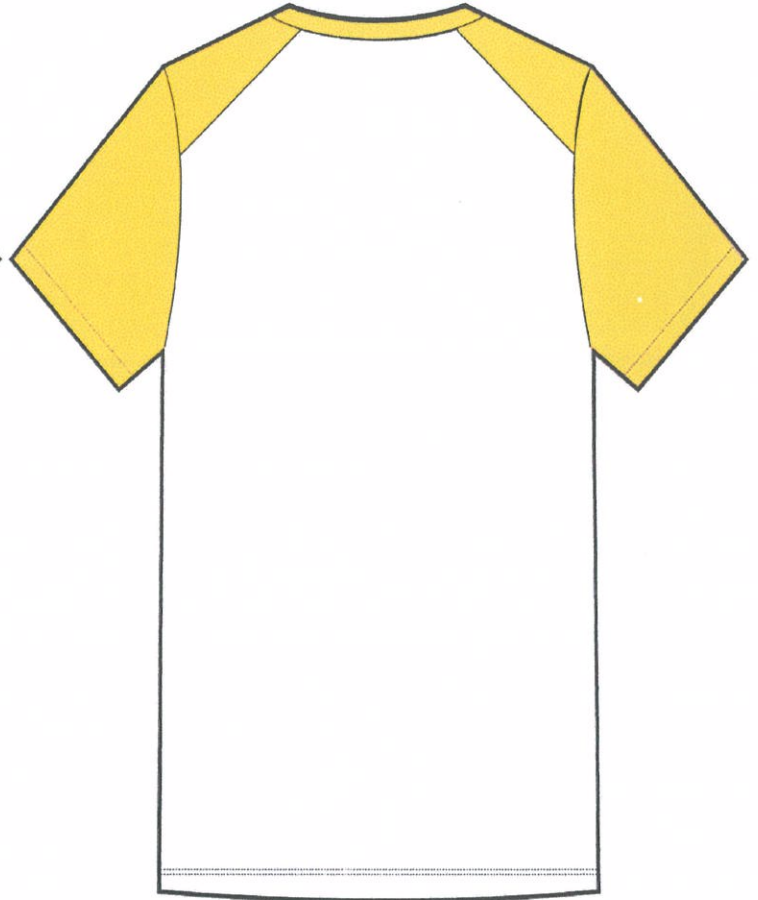

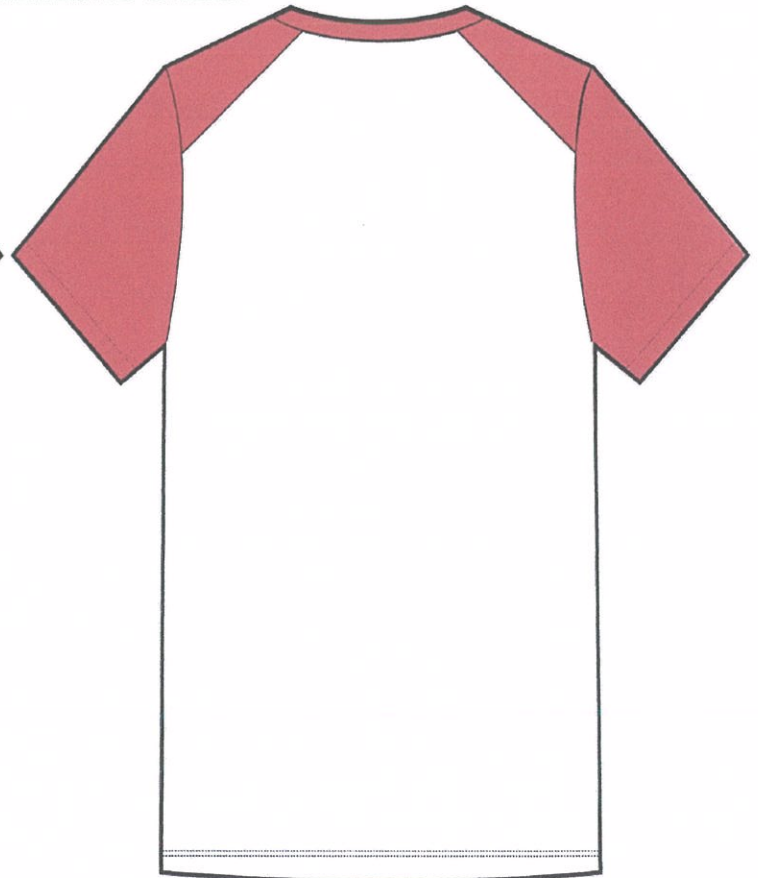

PROCUREMENT GROUP



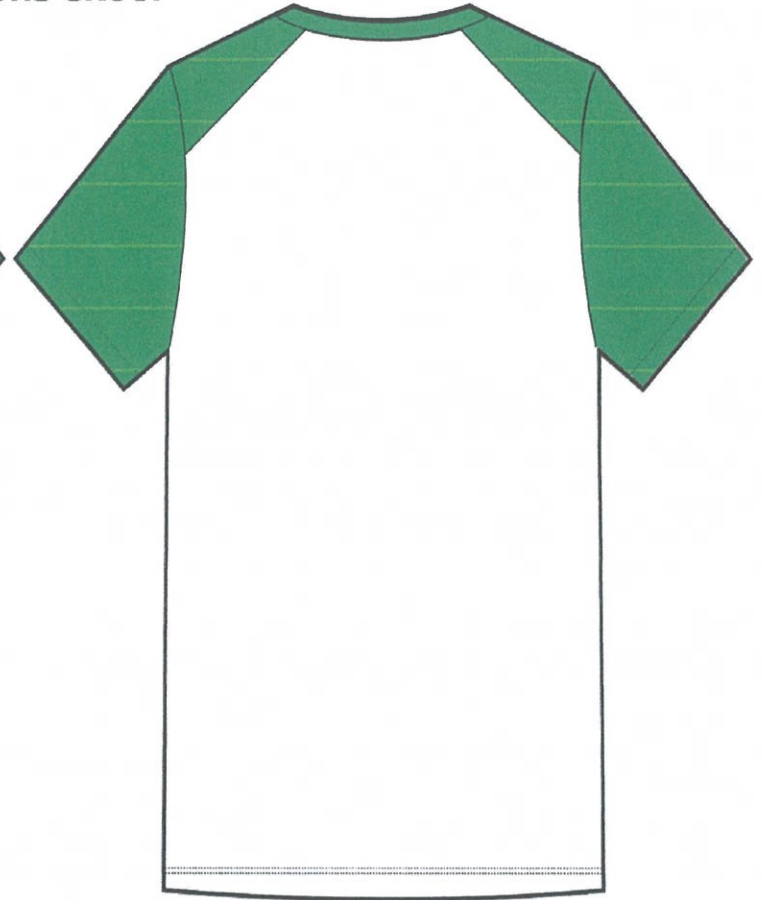
REGIONAL OPERATIONS GROUP



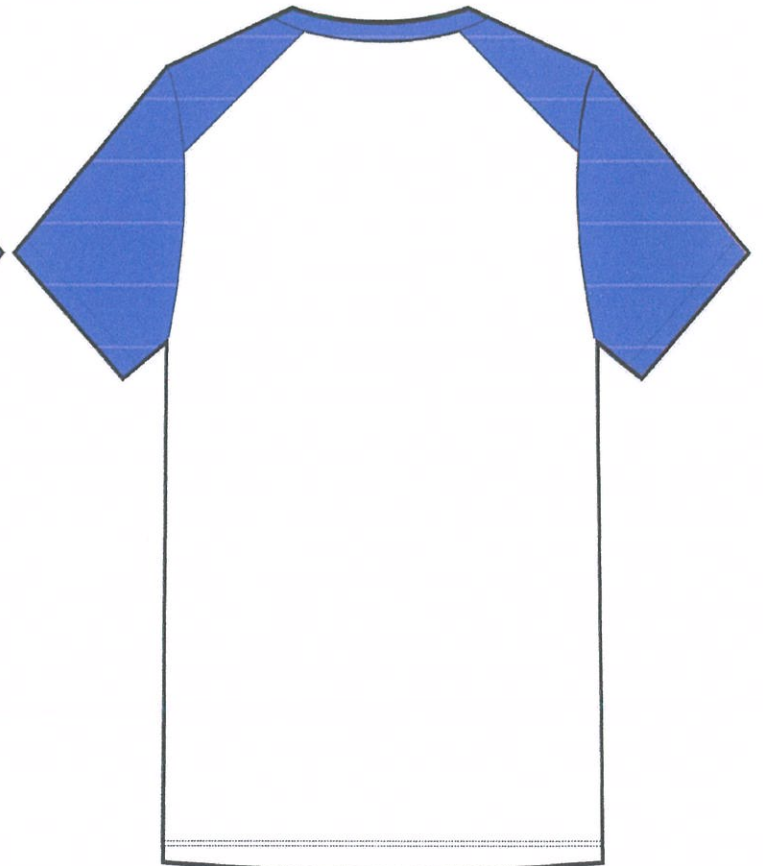
