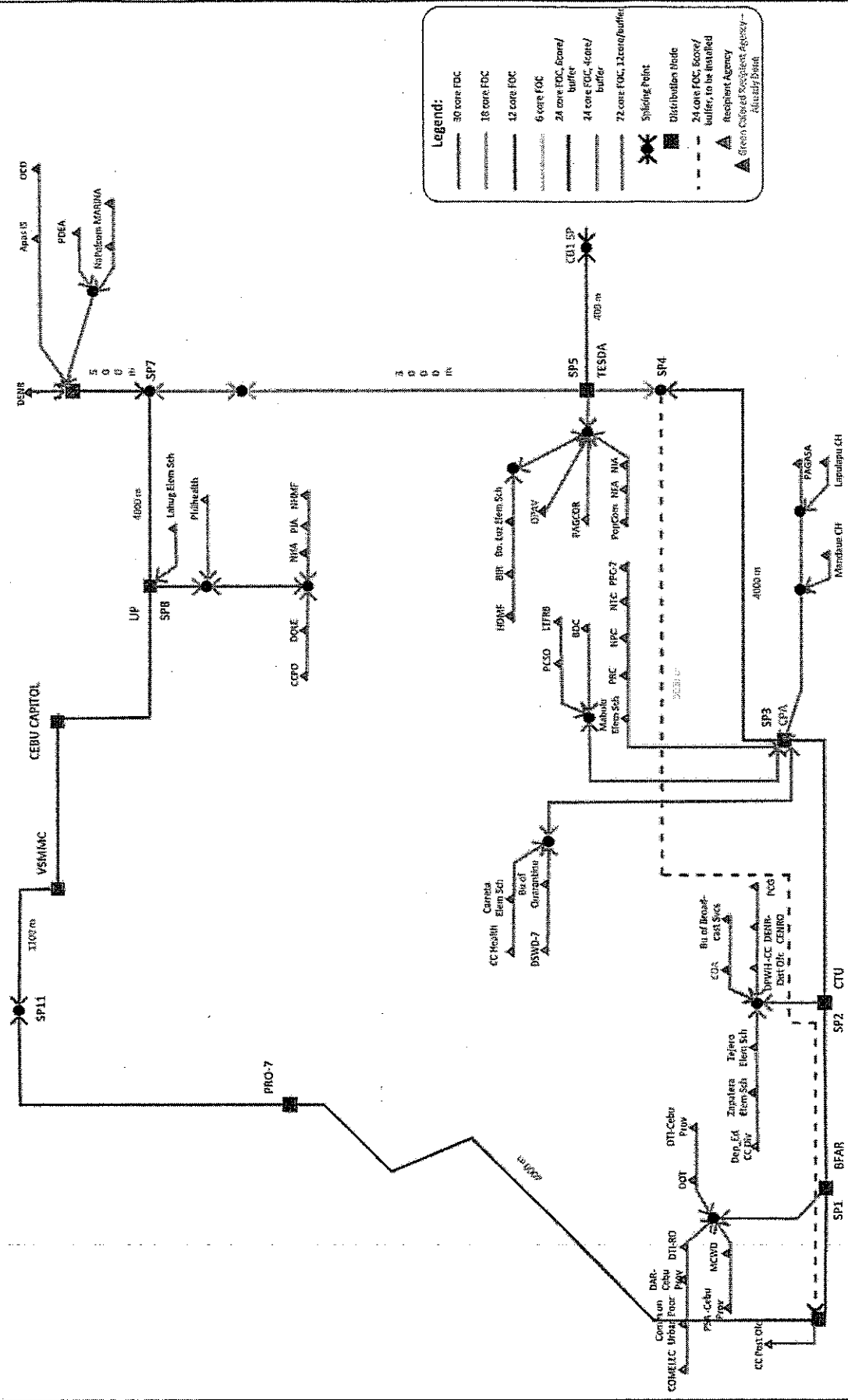
All other portions of the Bidding Documents affected by these amendments shall be made to conform to the same.
