PUBLIC BIDDING NO. 21-127-7

SUPPLY, DELIVERY, INSTALLATION, TESTING AND COMMISSIONING OF INTEGRATED BODYWORN CAMERA WITH WIRELESS TRANSMISSION FOR THE OFFICE OF TRANSPORTATION AND SECURITY

Issued pursuant to Sec. 22.5 of the IRR of R.A. 9184 to clarify and/or amend certain provisions in the Bidding Documents issued for this project, considering the issues raised and clarifications made by prospective bidders during the Pre-bid Conference held on **17 September 2021**, likewise, respond to bidders' written queries received within the prescriptive period for filing.

A. CLARIFICATION

The Department of Budget and Management – Procurement Service – Bids and Awards Committee VII hereby clarify bidders' concerns and queries.

12	These two foregoing ambush requirements referring specifically to body worn cameras is a failure of the BAC to align these two clauses to BDS Clause 5.3.a, which latter Clause should correctly prevail because it allows more suppliers to participate in the bidding; furthermore, it assures better chances for the item to be procured finally. If this were not an oversight on the part of the BAC, it would otherwise be very easy to prove that the bidding is being railroaded in favor of a supplier. Both clauses, BDS Clause 20.1.6 and Clause 20.1.8, should, therefore, also allow reference to surveillance equipment and CCTV Cameras.	Section III- Bid Data Sheet Clause 5.3 Page 19 a. Also, BDS ITB Clause 20.1.10 requires that "The system shall have two (2) years of hardware, software and labor warranty. This shall include a quarterly preventive maintenance service for the duration of the warranty period". With all due respect, we request that the BAC issue a categorical statement that the cameras would only be issued in the Manila Airport and not to provincial airports, as maintenance servicing under the latter would entail substantial cost to the goods would have to be issued outside of Manila, may we then propose a "carry-in" arrangement where the goods would have to be recalled to Manila by OTS for servicing (preventive maintenance) by the contractor on a quarterly basis. If this is not possible, RA 9184 requires you to be specific, as in how many units would be issued to which port in the country so that the bidder can correctly prepare his financial proposal. This would of course require you to estimate this additional cost and add this to your ABC	Section III- Bid Data Sheet Clause 20.1.10 Bullet 1 Page 21 The system shall have two (2) years hardware, software and labor warranty. 14	In the matter of the submission of POC Equipment and Materials, please review your numbers and correct your SIM card requirements to "24 minimum" as you only ask for 24 BWC POC units and your SIM card description is for "Globe OR Smart OR combination of both".		To clarify that each of the 24 BWCs will require a data sim. There is no specific requirement regarding the brand. Prospective bidder may use Globe, Smart or Dito. Prospective suppliers will not be restricted to 1 brand you may use 1, 2 or a combination of all 3 that are available in the market nationwide.
15	Due diligence review of your POC test procedures would have shown that you got distracted when writing down the test protocols and you forgot to finish them altogether, obviously. Please finish the test details and do not forget to invite the bidders to witness the tests, pursuant to the avowed transparency principle of RA 9184.		To clarify that the POC test procedures are complete and will allow TWG, End-user and Bidder's (issued LCB) representatives to witness such test in accordance with the parameters provided in the bid documents.
16	Please address your requirement of having to perform simultaneous tests at two different sites when in fact there is no connectivity specification for the system. If this cannot be reasonably explained, please simplify your POC tests to only one site then.	Section VII. Supplier must be able to provide the requirement for OTS to be worry-free from equipment downtime as we utilize the device at airports working under 24/7 operation.

			lull period even during the warranty period.

All other portions of the Bidding Documents affected by these amendments shall be made to conform to the same.

Amendments/inclusions/clarifications made herein shall be considered an integral part of the Bidding Documents.

The changes made in the Philippine Bidding Documents (6th Edition, July 2020) are deemed integrated in the terms and conditions for this project.
