- g. Affidavit to provide employee's welfare N.B. Documents submitted during post-qualification as part of post-qualification documents must be certified by the authorized representative to be true copy/ies from the original.

Submission of the documents may as follows:

In the absence of CTC, the BAC may require presentation of the original documents for the purpose of verification, validation, and ascertaining its authenticity.
