- 6. Certification from the bidder with proof that the motor vehicle to be supplied is **the latest model** being offered in the Philippines
- 7. List of Manufacturer's, Company-Owned or Accredited Service Centers:
  - a. Five (5) in NCR
- 8. Certification of Spare Parts Availability in the Philippines from delivery up to the next **five (5) years** after end-of-production issued by the manufacturer or authorized dealer.
- 9. Proof of DENR numerical emission standards compliance.

**Note:** All licenses, certifications, and permits including Mayor's/Business Permit, Business Registration Certificate, and Latest Audited Financial Statement required SHALL BE CERTIFIED /AUTHENTICATED as true copy of the original by the issuing government office or agency or private company. In the absence of CTC, the BAC may require presentation of the original documents for the purposes of verification, validation, and ascertaining its authenticity.

In case the PhilGEPS Certificate of Registration or any documents listed under its Annex A has expired after the bid opening, the bidder is required to submit the said documents anytime during the post-qualification stage or prior to Award.

N.B. Documents submitted during post-qualification as part of post-qualification documents must be certified by the authorized representative to be true copy/ies from the original.
