Issued pursuant to Sec. 51.5 of the IRR of R.A. 12009 to clarify and/or amend certain provisions in the Bidding Documents issued for this project, considering the issues raised and clarifications made by prospective bidders during the **Pre-Bid Conference** held on **05 June 2025**, likewise, response to bidders' written queries received within the prescriptive period for filing.

1	Mr. John Patrick Raquid of John Patrick Enterprises clarified whether the BAC still needs certification from the Insurance Commission for Surety Bonds. He also commented that the request and release of the certificate take time.	Section III: Bid Data Sheet ITB Clause 14.1	<p>The Bid Security serves as a guarantee of the bidder's commitment during the bidding process itself. Its purpose is to assure the Procuring Entity that the bidder will enter into contract and furnish the required Performance Security if awarded the contract.</p> <p>On the other hand, the Performance Security is required from the winning bidder to guarantee the faithful performance of the obligations under the awarded contract. It ensures that the contractor will complete the project or deliver the goods/services as stipulated.</p> <p>To avoid this onerous</p>

			requirement and streamline participation, bidders are strongly encouraged to utilize the Bid Securing Declaration as an alternative to a Bid Security.
2	Mr. Raquid requested clarification on the reckoning date of the physical submission.	Section III: Bid Data Sheet ITB 20.2 B. Physical submission	Physical submission of documents is required during the post-qualification period, reckoned from the date of receipt of the Notice of Single/Lowest Calculated Bid.
3	Mr. Raquid asked if the schedule of requirements still features structured tranche deliveries, similar to the previous bidding. .	Section VI: Schedule of Requirements	For this particular project, 26,000 pieces represent the maximum quantity under a framework agreement. Deliveries are required within 15 calendar days upon the issuance of each Call-Off, with the reckoning date beginning the day the Call-Off is received.
