<b>2</b>	Can Resellers participate in this procurement project?	Resellers can participate in the procurement project but shall be required to submit a certification from the manufacturer/s that they are Authorized Reseller/s.
<b>3</b>	Is provision of a demo unit required?	No. There is no requirement for the provision of a demo unit.
<b>4</b>	Can the prospective bidders purchase the Bidding Documents through bank payment?	No. The prospective bidders shall visit the PS-DBM Main Office located in R.R. Road, Cristobal St., Paco, Manila to manually pay for the Bidding Documents at the PS-DBM Cashier.
<b>5</b>	How many battery cells are required.	There is no information indicated on the technical specifications with regard to the quantity of battery cells required. The prospective bidders may provide their offers.
<b>6</b>	What is the scope of testing for the units?	Only basic testing shall be conducted by the PS-DBM Inspection Division which shall be based on the required technical specifications.
<b>7</b>	Are there applications that need to be pre-installed?	No. There are no required applications to be pre-installed.
<b>8</b>	Is the winning bidder required to assign a representative during the inspection?	Yes. The winning bidder shall assign a representative during the inspection of the delivered units.
<b>9</b>	Shall the PS-DBM require the winning bidder to initially inspect the units prior to delivery?	No. The inspection shall be conducted in the PS-DBM Main Office upon delivery.
