Section III. Bid Data Sheet

12.1(a)(i) Valid and current Certificate of PhilGEPS Registration (Platinum Membership).

The valid PhilGEPS Certificate of Registration (Platinum Membership) shall reflect the updated eligibility documents. Should any of the documents indicated in "Annex A" of the Certificate is not updated, The bidder shall submit the Certificate together with the updated documents.

Notwithstanding the above requirements, the bidder may opt to submit the following eligibility documents in lieu of the submission of the PhilGEPS Certificate of Registration (Platinum Membership):

- a. Business Registration;
- Mayor's Permit for 2018 or 2019. If the Bidder submits the Mayor's Permit for 2018, the submission must be accompanied by any verifiable proof that it already applied for the 2019 Mayor's Permit;
- c. 2017 Audited Financial Statement;
- d. Valid and current Tax Clearance Certificate;
- e. PCAB License, if applicable.

In the latter case, the bidder shall submit a valid and updated PhilGEPS Certificate of Registration (Platinum Membership) **including its Annex "A"** as part of post-qualification documents.
