1. The Government of the Republic of the Philippines has applied for financing from the Asian Development Bank (ADB) toward the cost of the **Davao Public Transport Modernization Project**. Part of this financing will be used for payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The **Department of Transportation (DOTr)** (“the Employer”) through its Procuring Agent, **Procurement Services - Department of Budget Management (PS-DBM)**, invites sealed bids from eligible Bidders for the design, construction and completion of the Works as broadly described above.
3. **Open Competitive Bidding (international advertisement)** will be conducted in accordance with ADB’s [Single-Stage: One-Envelope](#) bidding procedure and is open to all Bidders from eligible countries as described in the Bidding Documents.
4. Only eligible Bidders with the following key qualifications should participate in this bidding:

| | Personnel Assigned | Bidder must demonstrate that it has adequate Staff to meet the following: 1. The employer’s quality and safety requirements, and 2. Project timelines. [Ref: Vol 2, Sec 6] |
| Specific Experience | Construction of Large-Scale Earthworks | Bidder must have experience of at least one (1) project that has been successfully or substantially completed (80%) within the past ten (10) years involving large scale earthworks of at least 200,000 m ³ of cut or fill volume. |
| | Construction of Industrial Complexes | Bidder must have experience of at least one (1) project that has been successfully or substantially completed (80%) within the past ten (10) years involving construction of industrial complexes of at least 3,500 m ² of footprint size. |
| | Fabrication, Erection and Construction of Steel Structure | Bidder must have experiences of at least two (2) projects that have been successfully or substantially completed (80%) within the past ten (10) years involving fabrication, erection and construction of steel structure. |
| | Design of Multi-Disciplinary Project | Bidder must have experiences of at least two (2) projects that have been successfully or substantially completed (80%) within the past ten (10) years involving the design of multi-disciplinary project with disciplines including but not limited to site formation, industrial building, building services and steelwork where the construction cost exceeds USD One Hundred and Thirty-Two Million (\$132,000,000) |

 - write to the PS-DBM address above requesting the Bidding Document, if a hard copy is required.
 - pay a non-refundable fee of Philippines Peso Seventy-Five Thousand (PHP 75,000) for each set of the Bidding Document required, by cashier's check made payable to "Procurement Service". Cash payments at the above address are acceptable subject to issuance of an authenticated official receipt.

For the avoidance of doubt, the non-refundable fee of PHP 75,000 shall be paid by a Bidder before submitting its bid regardless of whether the Bidder obtains a hard copy of the Bidding Document or not. However, if a Bidder requests for a hard copy, the PHP 75,000 shall be paid upon the Bidder's request of the hard copy of the Bidding Document.

The Procurement Agent will hold a Pre-bid Conference on **05 April 2022 at 10:00 AM (GMT+8)** at the Procurement Service PS-DBM Compound, RR Road, Cristobal Street, Paco Manila 1007 Philippines which shall be open to all interested parties including those who have not purchased the Bidding Documents.

 - together with a Bid Security as described in the Bidding Document.
