The envelope shall contain the name of the contract to be bid in capital letters and bear the name and address of the supplier in capital letters.

To guarantee the faithful performance by the winning bidder of its obligations under the contract in accordance with the Bidding Documents, it shall post a performance security prior to the signing of the contract.

#### SCOPE OF WORK AND SPECIFICATIONS

### REPAIR AND REPLACEMENT OF WAREHOUSE ELECTRICAL FIXTURES FOR PS REGIONAL DEPOT - TACLOBAN

#### 1.0 DESCRIPTION OF THE PROJECT

PS Regional Depot Tadoban office and warehouse is a two-storey building located in the compound of the Department of Budget and Management (DBM) Marasbaras, Tacloban City. At present, the building has been experiencing fluctuating lights, with limited to no available lighting which affects the day-to-day operations of the depot. The intent of this project is to provide PS Depot Tacloban with a conducive working area and allow a smooth flow of operations.

#### 2.0 SCOPE OF WORK

The following is the scope of work of the project:

#### 2.1 Mobilization

Mobilization shall include the transferring to the job-site of all materials, equipment, personnel, and all items necessary for the execution and completion of work.

#### 2.2 Demobilization

Demobilization shall include dismantling, preparation and loading for removal of all equipment and personnel on site after completion of the works.

#### 2.3 Electrical Works

- Rewiring of all electrical lighting fixtures and connection to a new circuit breaker.
- b. Replacement of damaged fluorescent holders:
  - 8 pieces @ 1st floor
  - 4 pieces @ canopy
- c. Replacement of 18W LED Tube T8 light fixture:
  - 14 pieces @ 1st floor
  - 4 pieces @ canopy
  - 2 pieces @ lobby
  - 12 pieces @ 2nd floor



### 2.4 Clearing / Cleaning Works

The Contractor shall ensure that the construction site is clean prior to turn over to the end user.

### 6.0 TIAC INSPECTION

Once the project reaches an accomplishment of ninety five percent (95%) of the total contract amount, the Procuring Entity may create an inspectorate team to make preliminary inspection and submit a punchlist to the Contractor in preparation for the final turnover of the project. The punchlist will contain, among others the remaining works, work deficiencies for necessary corrections, and specific duration / time to fully complete the project considering the approved remaining contract time. This however, shall not predude the claim of the Procuring Entity for liquidated damages.

## 7.0 CERTIFICATE OF COMPLETION

The contractor shall request the Procuring Entity's Representative to issue a Certificate of Completion of Works, and the Procuring Entity's Representative will do so upon deciding that the work is complete.
