Quotations and other documents required **may either be submitted manually** at 2<sup>nd</sup> Floor Lobby Procurement Service Building Internal Bids and Awards Committee Bid Box **or electronically** to <u>internal-bacsec@ps-philgeps.gov.ph</u>, on or before the deadline of submission as stated in this RFQ. Bidders must only select one mode of submission. **In case of electronic submission, the proposal shall be in a password-protected compressed archive folder.** The passwords for accessing the file will be disclosed by the bidders only during the actual bid opening.

Unsealed or unmarked bid envelopes, or in case of electronic bid submission, proposals not in compressed archive folders and are not password-protected, shall be rejected. However, bid envelopes that are not properly sealed and marked or not properly compressed and password-protected, as required, shall be accepted, provided that the bidder or its duly authorized representative shall acknowledge such condition of the bid as submitted.
