This is with reference to the bidding conducted by the Bids and Awards Committee (BAC) of the Procurement Service of the Department of Budget and Management (PS-DBM), for the procurement of the EPCC Contract for the above-mentioned Project, wherein the bid of your company was declared to be the Single Calculated and Responsive Bid (SCRB). Failure on your part to submit the abovementioned documents and enter into contract within the period herein prescribed shall compel the BAC to impose the appropriate administrative sanction/s provided under the relevant provisions of the 2016 Revised Implementing Rules and Regulations of RA 9184.

Further to the EPCC Contract for the Project not becoming effective until effectivity of the Loan Agreement for the Project pursuant to Sub-Clause 1.6 of the Particular Conditions of the Contract, Clause 5 of the Contract Agreement, and Item 5 of the Clarificatory Procedures for the Implementation of the Note Verbale no. 17-1049, in relation to Note Verbale No. 17-1049 dated 03 March 2017 and the Note Verbale dated 08 March 2017 between the Government of the Philippines and the Government of the People's Republic of China, this NOA is being issued subject to your submission of your Philippine Contractors Accreditation Board (PCAB) License and the Department of Budget and Management's (DBM) issuance of the Multi-Year Contracting Authority (MYCA) for the Project, or equivalent, prior to the effectivity of this NOA. An unconditional NOA shall be issued upon your submission of the PCAB License and the DBM's issuance of the MYCA for the Project, or its equivalent.
