Supply, Delivery and Installation of Various Air-conditioning Units for the Bureau of Immigration

This AGREEMENT, made this 24th of November 2021 at the City of Manila, between:

BUREAU OF IMMIGRATION, of the Philippines, with principal office address at Magallanes Drive, Intramuros, Manila, Philippines, 1002, and, hereinafter referred to as the "**PROCURING ENTITY**";

and

the **ACMI OFFICE SYSTEMS PHILIPPINES INC.**, a corporation duly organized and existing in accordance with the laws of the Republic of the Philippines, with postal addresses at AYSN Building 268-A N. Domingo St., San Juan City, Metro Manila, represented herein by its Authorized Representative, **ROSEMARIE DELA CRUZ**, and hereinafter referred to as the "**SUPPLIER**".

WHEREAS, the PROCURING ENTITY invited Bids for the **Supply, Delivery and Installation of Various Air-conditioning Unit for the Bureau of Immigration** and has accepted a Bid by the SUPPLIER for those goods in the sum of Fourteen Million Four Hundred Twenty-Six Thousand Pesos (Php14,426,000.00) inclusive of all applicable taxes, hereinafter called the "**CONTRACT PRICE**".

AGREEMENT WITNESSETH AS FOLLOWS:

1. Words and expressions herein stated shall have the same meanings as are respectively assigned to them in the General and Special Conditions of Contract, attached and made an integral part of this agreement.

 - b) The Schedule of Requirements;
 - c) The Technical Specifications;
 - d) The General Conditions of the Contract;
 - e) The Special Conditions of Contract; and
 - f) The Procuring Entity's Notification Award.
3. In consideration of the payments to be made by the PROCURING ENTITY to the SUPPLIER as hereinafter mentioned, the SUPPLIER hereby covenants with the PROCURING ENTITY to provide the goods and to remedy defects, in conformity with the provisions of this Agreement and the documents herein attached.

4. The PROCURING ENTITY hereby covenants to pay the SUPPLIER in consideration of the provision of the goods and the remedying of defects, the Contract Price or such other sum as may be allowed and become payable THIRTY (30) DAYS after acceptance and full delivery, installation of the **Various Air-conditioning Unit** and in the manner prescribed in this Agreement and the documents herein attached.


