Subject to the following terms and conditions, to wit:

- 1. Bidders are required to enclose / post a Bid Bond in the form of Cash, Cashier or Manager's Check equivalent to Ten Percent (10%) of the Floor Price. All Bonds of non-winning bidders are refundable immediately after selection of winning bidder. However, the winning bidder's bond shall only be withdrawn upon perfection/ completion of the contract.
- 2. Floor Price of the Property for sale is Twenty Six Thousand Pesos (Php 26,000.00), non-negotiable and on an "As-Is-Where-Is" basis.
- 3. All expenses related to the hauling of these items shall be borne by the buyer.
- 4. Date of completion and full payment shall be made not later than three (3) Calendar Days upon issuance of notice of awards.
- 5. Non-compliance of the winning bidder on the above stipulated Terms and Conditions shall be grounds for the rejection of the bid without prejudice to a re-bidding as the situation warrants.

The bidder is encouraged to conduct an ocular inspection of the property for sale before submitting his/her proposal.

Contract of Conveyance shall be executed by the PS-DBM Executive Director as Head of the Agency in favor of the winning bidder immediately after the Notice of Award has been served to the letter.
