In reference to the Memorandum Circular No. 2021-1 and Memorandum Circular No. 2021-2 (Supplemental Guidelines) cascaded by the Inter-Agency Task Force on the Harmonization of the National Government Performance Monitoring, Information and Reporting Systems (Administrative Order No. 25 s. 2011) on the criteria and conditions for the grant of the Performance-Based Bonus (PBB) for Fiscal Year (FY) 2021.

Under 4.3 and 2.3 Financial Results of the Memorandum Circular No. 2021-1 and Memorandum Circular No. 2021-2 (Supplemental Guidelines) respectively, both Budget Utilization Rate (BUR) and Budget and Financial Accountability Reports (BFARs) are requirements for the grant of PBB.

A Certification was previously issued to the Procurement Service-Department of Budget and Management (PS-DBM) from the DBM Budget and Management Bureau-C (attached as Annex "A") which states that:

- 1.0 PS-DBM has no annual budgetary support from the National Government;
- 2.0 PS-DBM uses its Revolving Fund for its operating requirements as authorized under Letter of Instructions No. 755;

The Procurement Service-Department of Budget and Management (PS-DBM) has no programs, activities, and projects funded in the FY 2021 General Appropriations Act (GAA), hence, BUR and BFARs are not applicable for the PS-DBM as the agency is income generating and self-liquidating.
